TERMS AND CONDITIONS

All dogs over 4 months of age entering the property of Laws for Paws Qatar training school must be fully vaccinated. Puppies younger than 4 months that have not yet had their rabies vaccines will be admitted, but proof of vaccine must be shown once the puppy has received it. Laws for Paws Qatar will not be held liable for any losses, damage to property or injuries sustained while on the training school's property. Dogs will be kept under control, by the owner/handler at all times. It is up to the owner/handler to disclose any temperament issues that the dog might have, before classes commence.

Un-neutered bitches in season will not be admitted to class. Please inform Laws for Paws Qatar management of this situation. A make-up class can be scheduled for bitches that miss out due to being in season.

There will be a strict policy of one dog per owner per class. Additional dogs will be allowed if they are handled separately, i.e., another handler. Please note it is the owner/handlers responsibility to find additional handlers for their/or extra dogs. In the case of owners that will have two dogs in different classes, please make arrangements for the safe custody of the non-working dog. Dogs tethered to the side of the field will not be allowed.

Property belonging to Laws for Paws Qatar is to be treated with respect and will not be removed from the training area.

Training techniques used by the Laws for Paws trainer will be accepted as the method of training used by Laws for Paws Qatar. No discussion will be entered into.

Dogs are allowed to be walked before and after class but please make sure that you have scooped any areas your dog might have defecated. Behavioral problems flagged during classes that cannot be dealt with during class can be handled on a one-on-one basis, at an additional cost. Training fees are due and payable on the first day of commencement of the training course. Missed **group classes will be forfeited. One-on-one** training clients may reschedule **one class** in case of an emergency. Thereafter re-scheduled classes will be charged for at the rate of QR250. In case of assessments a QR500 charge will be levied. QR500 will be deducted from the training fee if the client decides to commence a full **one-on-one** training course, after the assessment. An additional QR500 will be added to the training fee if client is in any of the following areas: Dukhan and surrounding areas. Al Khor and surrounding areas, Karatiyat, Um Salal Mohammed, Um Salal Amad and surrounding areas. Mesaaied and surrounding areas.

Refunds in the case of **one-on-one** training clients will be at the discretion of Laws for Paws Qatar management.

Minimum age of handlers is 12 years old.
